





計劃條款與條件

概述

- 1. 通過參與香港國際機場貨運數據平台香港進出口報關單元獎勵計劃(「本計劃」),每位平台用戶確認同意這些條款和條件。
- 2. 本計劃有效期間爲 2025 年 7 月 1 日 00:00 至 2025 年 12 月 31 日 23:59(香港時間)(下稱「計劃期」)。

<u>資格</u>

- 3. 本計劃只開放予符合以下所有要求的公司:
 - a. 該實體是已成功在香港國際機場貨運數據平台(「平台」)註冊帳戶的註冊公司。
 - b. 以及收到香港機場管理局(「機管局」)電郵邀請的註冊公司。

獎品和兌換

- 4. 所有獎品均不可轉讓,不可兌換現金或其他產品。
- 5. 獎品-合資格公司可根據以下兩種獎勵計劃獲得獎勵。

計劃一: 開戶贊助計劃

- (a) 在計劃期內, **首 15 間** 完成以下**所有**獎勵要求的公司將獲得價值港幣 **\$1,000** 元的超市 禮券:
 - (i) 成功登記使用 BRIO 的報關服務;
 - (ii) 將其 BRIO 系統帳戶連接至平台的香港進出口報關單元;以及
 - (iii) 提交 5 份進口或出口報關申報(系統狀態爲「傳送至政府」)(每份爲「傳送至政府」,合稱「傳送至政府」)。
- (b) 如對系統狀態或完成第 5 份已接納申報的時間有任何爭議,以平台的記錄爲最終及具約束力的依據。
- (c) 附有獎品兌換說明的電子郵件和郵件通知將發送到獲獎者在平台註冊帳戶時提供的註冊電子郵件和辦公位址。
- (d) 寄送或領取獎品將於 2026 年 1 月 31 日或之前安排,由機管局酌情決定。

計劃二:每月用量獎勵

(a) 在計劃期間內,每間公司如達到以下每月透過平台提交的進出口報關申報數量目標(系統 狀態爲「傳送至政府」),即可獲得以下獎勵:

每月遞交>20-49單	價值 \$400 港元之超市購物禮券
每月遞交 50 - 99 單	價值 \$700 港元之超市購物禮券
每月遞交>100單	價值 \$900 港元之超市購物禮券

- (b) 每月透過平台提交的進出口報關申報(系統狀態爲「傳送至政府」)的統計截止日期及時間爲該月最後一個曆日的香港時間 23:59。如對系統狀態有任何爭議,以平台的記錄爲最終及具約束力的依據。
- (c) 附有獎品兌換說明的電子郵件和郵件通知將發送到獲獎者在平台註冊帳戶時提供的註冊電子郵件和辦公位址。
- (d) 寄送或領取獎品將於每月截止日期後 1 個月內安排,由機管局酌情決定。

其他

Terms & Conditions

General

- 1. By participating in the HKIA Cargo Data Platform Trade Declaration Module Award Program (the "Program"), each company confirms that it agrees to these terms and conditions.
- 2. This Program runs from 00:00 on 1st July 2025 to 23:59 on 31st December 2025 (Hong Kong Time) (the "Program Period").

Eligibility

- 3. The Program is only open to entities who fulfill all of the following requirements:
 - (a) The entity is a **registered company** who has successfully registered an account at the HKIA Cargo Data Platform (the "Platform"); and
 - (b) The **registered company** who has received this email invitation from the Airport Authority (the "AAHK").

The Prize(s) and Redemption

- 4. All prizes are non-transferable, non-redeemable for cash or other products.
- 5. Prize(s) Eligible company can be rewarded based on the two plans below:

Plan 1: Account Creation Sponsorship Program

- (a) During the Program Period, the **first 15 companies** that completed **all** of the following award requirements will receive supermarket coupons worth HKD **\$1,000**:
 - (i) successfully register for BRIO's trade declaration services;
 - (ii) connects its BRIO system account to the Platform's Hong Kong Trade Declaration module; and
 - (iii) submit 5 import or export trade declarations (with system status "Accepted") (each an "Accepted Declaration" and collectively the "Accepted Declarations").
- (b) In case of dispute as to the system status and the timing of completing the 5th Accepted Declaration, the Platform's records should be final and binding.
- (c) Email and mail notifications with instructions on redemption of the prizes will be sent to the winning company's registered email and office addresses as provided upon account registration in the Platform.
- (d) Delivery or collection of the prize(s) will be arranged on or before 31st January 2026, the arrangement of which shall be determined by AAHK at its discretion.



Plan 2: Monthly Usage Rewards

(a) During the Program Period, each company can receive the following reward if it meets the following monthly target quantities of import or export trade declarations submitted via the Platform (with system status "Accepted"):

Number of Import or Export Trade Declarations Submitted via the Platform (with system status "Accepted")	Reward
Submitted > 20 – 49 in 1 calendar month	нк \$400 Supermarket Coupons
Submitted 50 – 99 in 1 calendar month	нк \$700 Supermarket Coupons
Submitted > 100 in 1 calendar month	нк \$900 Supermarket Coupons

- (b) The cut-off date(s) and time for calculation of the import or export trade declarations submitted via the Platform (with system status "Accepted") will be 23:59 Hong Kong time of the last calendar day of each month. In case of dispute as to the system status, the Platform's records should be final and binding.
- (c) Email and mail notifications with instructions on redemption of the prizes will be sent to the winning company's registered email and office addresses as provided upon account registration in the Platform.
- (d) Delivery or collection of the prize(s) will be arranged within 1 month after the cut-off date in each month, the arrangement of which shall be determined by AAHK at its discretion.

Others

- 6. AAHK accepts no liability for any damage, loss (including but not limited to direct, indirect and consequential loss) incurred or suffered by any participating company in connection with this Program.
- 7. AAHK accepts no responsibility in relation to quality of the prize(s) involved in the Program.
- 8. AAHK reserves the right to change, suspend or terminate the Program and amend these terms and conditions from time to time without prior notice. AAHK will not be liable for any loss due to these changes.
- 9. In case of any dispute arising out of this Program, the decision of AAHK shall be final and conclusive.
- 10. In case of any discrepancy between the Chinese and English versions of these terms and conditions, the English version shall prevail.
- 11. The Program shall be subject to and governed by the laws of Hong Kong.
